Our middle school programming is centered around a rigorous math and logic curriculum designed to improve critical thinking, literacy, and self-expression, as well as prepare them for admittance to competitive independent high schools. YES-LA serves scholars across Greater Los Angeles County—from Watts, Inglewood, & South Bay to East Los Angeles, Boyle Heights, & downtown Los Angeles. In New York City, scholars are identified from six public schools in Harlem District 5. YES-Chicago serves students from the South Side and West Side, and our Appalachian scholars are identified in rural public schools in Watauga & Ashe Counties in Western North Carolina. YES currently serves over 720 students across the country and grows by approximately 75 students annually.
